-Elizabeth St. Manhole Repairs Update

One manhole has been completed and they are working on the other. Will be moving to Lake St. south once they are done on Elizabeth St.

October 1 rain event. Iron River Rd. washed out again but the big culverts stayed in place. Road crew was able to get one lane open by lunch and both lanes by day end. Further up on Iron River Rd. by Mitchells and that corner is in rough shape again and Mitchell's driveway needed repair also. Robinson driveway on Watson Rd. washed out again and has been repaired along with a driveway on King Lane. For the most part we were pretty luck and the road crew did a great job getting everything cleaned up. We need to get Tulloch in to look at the culverts on Iron River Rd. and see what we can do there to make it stronger so this doesn't keep happening. Mayor Watson suggested putting back the debris catcher upstream to catch a lot of the debris that gets washed down there. A lot of junk is in those culverts so when we have a rain event it can't get away fast enough and goes over the road. More discussion required.
