ECHO BAY WATER DISTRIBUTION FLUSHING

Ontario Clean Water Agency will be performing the annual preventative maintenance in the distribution system between June 15^t and 19th. Flushing of hydrants and exercising of valves will take place during this time. Residents may notice low water pressure and/or discoloured water during this process. If you experience discoloured water, please run your cold water tap until the water runs clear.

BE CAREFUL WHAT YOU FLUSH

We recognize that many residents may be increasing their use of disinfectant wipes, paper towels and facial tissues in response to COVID-19. We would like to remind residents not to flush wet wipes of any kind. Despite what some packaging says, wipes are not flushable. Paper towels and facial tissues also do not belong in the toilet because they do not break down like toilet paper does. If these items are flushed they can cause blockages in pipes which may lead to sewage overflows in your home or business. They can also clog sewers and cause costly damages to local wastewater infrastructure.

REMEMBER THE 3 "P" that are flushable PEE, POOP AND PAPER (toilet paper)-NO EXCEPTIONS!

DUE TO COVID-19 RESTRICTIONS WATER METERS WILL NOT BE READ ON JUNE 1. WE WILL BE BILLING ONCE AGAIN ON THE BASE AMOUNT ONLY.
