MUNICIPAL ELECTION 2022

NOMINATION NOTICE

Any person planning to seek office in the 2022 Municipal Election must file a nomination form with the Clerk or delegate before any money is spent or raised for campaign activities.

As of Monday May 2, 2022 nominations may be made by completing and filing at the Clerks Office nominations on a prescribed form and accompanied by the prescribed nomination filing fee of \$200.00 for Head of Council and \$100.00 for all other offices payable by cash, certified cheque, money order or debit.

Nomination forms are available at the Municipal Office located at 208 Church St Echo Bay, ON during regular office hours 8:30 – 4:30 Monday to Friday. A nomination form must be signed by the candidate and may be filed in person or by an agent during regular business hours between May 2, 2022 and Thursday August 18, 2022 and between 9:00 a.m. and 2:00 p.m. on Friday August 19, 2022 (Nomination Day). All completed and filed forms are public documents.

A person is qualified to be elected or hold office who, as of the day they file their nomination:

1. Is a Canadian Citizen
2. Is at least 18 years of age, and
3. Resides in the local municipality, or is the owner or tenant of land in the local municipality, or the spouse of such a person
4. Is not disqualified by any legislation from holding office.

In the event there are an insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday August 24, 2022 between the hours of 9:00a.m. and 2:00p.m. and such additional nominations if required may be filed in the Clerk's Office.

EMERGENCY MANAGEMENT

We would like to thank everyone in the Village of Echo Bay for complying with the Water Conservation Order that was required due to an oil spill from Algoma Steel on June 9, 2022. Due to the capacity of our Water Tower and with the cooperation of everyone we were able to provide enough water to sustain our community during this emergency.

Thank you to our Community Control Group and CEMC David Jackson for overseeing the coordination of this emergency and Ontario Clean Water Agency, Ministry of Environment and Algoma Public Health for their professionalism and expertise. After multiple water sample tests have confirmed that it is safe to resume consumption the Water Conservation Order has been lifted. The Township received a letter from the President/CEO of Algoma Steel stating that they will be covering the cost of providing clean drinking water to our treatment plant during this emergency. Once we have received all expenses related to this emergency, we will be invoicing Algoma Steel for a full cost recovery of this emergency.
