-Echo Lake Road Stabilization Project

Phillips Contracting has added construction signs to the project area. Locates have finally been received and they have begun replacement of entrance culverts.

Waiting for locates to complete the installation of culvert on Birch Lake Rd.

-Repair on Watson Road

RS-1 emulsion with surface treatment gravel was applied to Watson Rd. near Ken Findlay's but did not give the results hoped for. May try another application using more sand like material.

-Cottage Road

Met with contractors on Cottage on Sept. 13, 2022, to discuss the widening of the road and removal of a couple large trees. Received quotes from Phillips and Karhi with suggestions on how to improve the road. Road Super to take this information and make a recommendation at the next Council meeting. -Hurley Park Site Preparation

Fill was brought in to begin the preparation for the installation of the playground equipment next spring. It looks good. Ditching needs to take place on the back of the property as well as the east side. Need to discuss if a fence will be installed on the east side and if so, the ditch will have to go further to the west on that property line to allow for the installation of the fence.

-EARS Meeting

Met on September 14 in Little Rapids. The main topic of discussion was surface treatment and how the majority of municipalities was not satisfied with the work provided by Elwood Robinson. For the most part they did a good job here but a lot more gravel is being used then necessary leaving a surplus on the shoulders of the roads which then ends up in our ditches. People are not happy when we plow the gravel into the ditches/yards, and they have to do clean up in the spring. Elwood Robinson is supposed to attend the next EARS meeting for more discussion.

b) Leisure Services Coordinator

-Sportsplex

Have not had anyone step up to be the lead for the Youth Hockey Program.

Does not seem to be any interest in curling so we probably will not be putting the curling lines on the ice surface this year. The curling rocks that were donated will be returned but we still have our curling rocks if there is an interest in the future.

Community Market is scheduled for September 21. 8-10 Vendors will be there. Thinking of doing another around for Christmas late November or December.

Ice Rentals are filling in Monday – Thursday as well as weekend.

Billboard advertising fee for the Sportsplex is being finalized.

Playground Equipment has been removed and the Roads Department have brough in a quite a bit of fill and leveled it off. Perimeter ditching along the south and east sides in next to be completed once locates have been confirmed. Fence on the East side to be decided because the location of the ditch will have to be confirmed to accommodate the fence. Looking great and should be ready for spring installation of new Playground Equipment.

-Farmers Fall Run

47 people participated in the 5 km route and 17 in the 1-2 km route. Great turnout and the weather held out. Discussed the potential of a new route for next year where Hwy 17 B would not be used. LSC said she will definitely look at that for next fall.
