Electors should examine the list to ensure that their names and relevant information are correctly shown. The Preliminary List may be amended between September 1, 2022, and October 21, 2022 inclusive during regular office hours (8:30 a.m.-4:30 p.m.) and on October 24, 2022 (Election Day) until 8:00 p.m. Applications for additions, corrections or deletions from the list may be made by an elector by completing and filing a form obtained from the Municipal Clerk's office.

No person shall use information obtained from the Preliminary List of Electors except for election purposes.
