RE: Sewage System Program 2024 - Algoma Public Health

Thank you for the continued collaboration with our Agency. We would like to provide some information for the 2024 Sewage System Season.

We wish to advise that our fees for services will be increasing for the 2024 year, however, our Agency has conducted a costing review with these increased costs and have determined that the increase will allow the program to continue to operate within the cost recovery as stated in the Act/Code. This increase has come into effect January 1, 2024. We have provided you with a copy and it is also available on our website.

As in previous years, we are still experiencing a workforce decline for the Sewage System (Part 8) program. Please be advised that same day or next day response for inspections and/or site meetings may not occur as frequently as in past. Planning ahead for inspections/site meetings with the sewage system inspectors would be greatly appreciated.

Sewage System Applications

- Please ensure **all** information on the <u>application</u> is complete. Ensure email address for owner is clearly written for distribution of permits once approved.
- We require roll number and legal description on all applications. This information can be found on all property tax documents. If no roll number provided due to creation of new lot then please provide neighboring roll number for filing purposes.
- > Test holes are required at all sites unless you have spoken to the area inspector concerning the site.

- Every sewage system installation must be inspected prior to backfilling. Notify the inspector of any planned installations in order to ensure inspection occurs in a timely manner.
- > Covering the system and taking pictures is not going to be accepted and the installer will be required to uncover the system.

Installer Information

- All Building Code Identification Numbers (i.e., license) must be current on the Ministry of Municipal Affairs and Housing database QUARTs.
- > Email will be used as the preferred delivery method for all approved applications, permits, receipts, etc. on files unless otherwise stated.
- > If you are unsure about your BCIN status, please reach out to the Ministry of Municipal Affairs and Housing for assistance.

Fees

- > For the 2024 Sewage System Program season there will be a fee increase, please view by visiting our website.
- Applications will not be reviewed, nor site visits will occur until payment is received by our office. If an installer wishes to meet onsite, the application can be provided to the inspector and payment must be received on the same day or next day for the file to be processed.
- Payment can be received by cash, cheque (made payable to Algoma Public Health) or credit card. Preferred method is by credit card.
- For payments over the phone with a credit card, please call the Environmental Health team at 705-759-5286 or visit one of our office locations.

Land Use Applications:

- > Please ensure all land use applications are received prior to Council meetings, we require a fee for these applications to be processed and will **not** submit notice of decision until payment is received.
- Performance Level Reviews are not only for additions within a dwelling but also for additions of accessory buildings and dwellings onto a property. We encourage all planning boards to advise owners to seek our confirmation of the addition to ensure the addition will not interfere with the existing system but also that the space being used for the addition will not be needed for a replacement sewage system in the future.

Exemptions for Severance Applications:

Unless exempted below, each application for consent, severance, minor variance, zoning amendment, will be as listed in the above fee schedule.

Lot fees are exempt under the following conditions:

- 1. The property is served by a sewage works designed for a daily sewage flow in excess of 10,000 litres per day, which has been, or requires approval by the Ministry of Environment, Conservation and Parks (MECP) under the Ontario Water Resources Act.
- 2. Any lot municipally serviced (sewer and water), with a letter stating services are available from the municipality.
- 3. Any parcel which comprises, or will comprise, part of a public highway.
- 4. Any lot or property transfer which is for the purposes of an easement, unless the easement is for the purpose of permitting the installation of a sewage system, <10,000 litres per day.
- 5. An application for a re-zoning or minor variance on a parcel for which a consent to sever fee had been collected during the same construction year.
